

Al Boring completed an evaluation of 4 Year Concession Stand Performance. In 2010, Season costs were \$ 13,974.65. Season Revenue was \$ 23,889.00 with a season margin percent of 41.5 %. Over the 4 years, season cost increased 12 % while season revenue increased 15 % and season margin % increased 2.1 %. Al also stated that food items were missing from the concession stand during the September work day at the field. It was also noted that the following vandalism occurred at the field: the new equipment door was smashed, batting cage net was cut in an attempt to steal the pitching machine, and bench was thrown over the bank. Request was made to change the locks at the concession stand. Water still needs shut off in the concession stand. Jackson Twp will take care of the restrooms.

Bruce Baker stated that anybody at the field after dark will be fined by the Jackson twp police. Evidence was given back to ETJ from the concession stand break in. A warrant has been issued for arrest of a person. Township and ETJ are looking into cameras.

Al Boring stated that Atlantic Board band will no longer do the website. Tracey Heeney has volunteered to take over the website.

Paul Wyrwas priced replacing the concession stand doors, roll down front doors from 84 Lumber at approximately \$ 1,200. Request made that these doors have bolt locks.

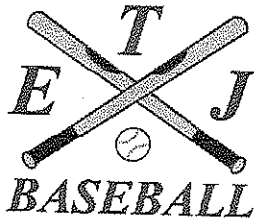
Marty Bezek requested for a fund raiser person and sponsor person for upcoming season. A request was made to increase the buy out and sign up fee.
